**NOTICE INVITING TENDER**

Slead Tender are hereby invited by the undersigned from the bonafied and experience enlisted constructors of this Panchayat Samity, Labour Co-operative Contractors / Registered Co-operative Societies formed by unemployed Engineers having credential of similar type of work and they have to abide by the following conditions:

1. Application for Tender Papers should be submitted to the Executive Officer or the undersigned during office hours up to 3:00 P.M from 12/09/2009 to 13/01/2009 along with valled S. Tax, I. Tax PTCC, and credential (In the form of the Payment Certificate and Completion certificate of a single work) of the EIC must be submitted in original and Photography thereof.

The original Papers will be return after scrutiny and the Photography will be preserved either by the Executive Officer or by the undersigned. Payment Certificate must be of last four years of similar type of work done by the Contractor. Partnership deed and other relevant paper (in case of registered farm/company) should be produced at the time of application if required.

2. Tender Papers will be issued to the qualified contractors up to 3:00 P.M. from 15/01/2009 to ..... The undersigned is not bound to issue the Tender Papers to all the applicants. Decision of the Executive Officer or the undersigned regarding issue of Tender Paper is final.

3. Tender Paper will have to be send by registered post or by Courier Service or by hand and it should reach either Executive Officer or the undersigned within 2:00 P.M. on.16/01/2009 Tender Paper received after the scheduled time & date will not be entertained. It will be opened on the same date & fixed time at the Office of the Executive Officer at 3:00 P.M. The intending Tenders may remain present at the time of opening of the Tender.

4. Time is the essence of contract. The successful Contractor must complete the work within the time specified for completion. No extension of time will be allowed except in special case. If any contractor fails to complete the work within the stipulated time the Work Order issued in this favour will be cancelled within assigning any reason thereof. The undersigned may also proceed to get the balance work completed by any other means including through other contractor. The excess expenditure, if any, due to such a step would be recoverable from the unpaid bills / security deposit of the Tender. This is a part from any other \* measure the undersigned may take including black listing of the contractor any forapiture of earnest money.

5. Earnest money noted against the name of work @ 2 % of the value of work will have to deposited in the form of pledge N.S.C. or Nationalized Bank Draft in favour of the undersigned. The earnest money will be converted into security money after acceptance. Balance 8% security money will be deducted from the bill to constitute 10 % security money. The security money will be released as per norms. Engineer Co-operative will not be required to be deposit any earnest money.

6. The rate should be quoted in percentage both in figured as well as in works. If the Tender amount is less than 15% of the estimated amount, an analysis of the Tender Amount would have to be provided.

7. Incomplete Tender will be rejected summarily. The successful Tender will have to execute a formal agreement on a non-judicial stamp worth Rs. 10/- ( Ten ) within Ten days from the date of issue of work order.

8. Audit report of last financial year 07-08 will have to be submitted in case of engg. Co-operative and Labour Co-operative Society. The Tender Form are to be received by the Chairman of Secretary of the Society . No Tender Form will be handed over to any outsider. Credential of similar type of works will have to be produced in case of engg. Co-operative and Labour Co-operative.
9. All work will have to be done according to specification and drawing approved by authority and as per direction of the E.I.C.
10. No consumable materials will be supplied to the agency for any work from the office of the undersigned .Agency will be responsible for procuring all materials required for proper execution of work at his own cost.
11. Bitumen will be supplied by the contractor with his own arrangement subject to submission of valid document at I.O.C.
12. For construction of Black Top Road , power roller of 8 to 10 Ton., hand -roller and miller mixer /spot mix plant of 3 to 5 Ton hour capacity must be arrangement by the contractor of his own cost.
13. All rates shall be inclusive of all charges, royalty, toll charges, carriage etc.
14. Before starting the work site must be dressed and cleared by cutting all sorts of jungles shrubs etc. for which no extra payment will be made.
15. Only 1 (One ) Tender Form will be issued to each contractor.
16. Any rate above 5 ( Five ) of the scheduled rate of work will not be ordinarily entertained.
17. The contractor who will not submit Tender Paper or do not return the same before the date and time of dropping after receiving the same will not be allowed to participate in two consecutive tenders.
18. The successful tenderer will have to start within seven days from the date of issue of work order after execution of formal agreement as per rule and will have complete the work within the time allowed for completion.
19. Acceptance of the lowest order is not obligatory and the undersigned reserves the right to accept of all the tenders without assigning any reason what so ever and also to split up the tendered work to more than one contractor in the interest of scheme execution.
20. Amalgamation of Unemployed Engineer Co-operative and Labour Co-operative in any form should be allowed towards counting of eligibility in participation of tender .
21. S.T./I.T./Royalty at the prescribed rate will be deducted at source.
22. The notice shall form part of terms & conditions of tendered shall be bound to abide by them.
23. Before submission of the tender the contractor must visit to work site to judge the local condition from all corners and no plea / complain about the site will be entertained after works . It will be presumed that the agency offered the tender after reviewing entire position of the work side.
24. Separate tenders should be submitted in similar way for each work of group of work.
25. Before submitting tender must get his signature attested on the contract form by witness failing which tender may be liable to be rejected.
26. All working tools and plants and implements required for the work are to be arrangement and supplied by the successful tenderer at his own cost.
27. The successful tenderer will have to abide by the provision of West Bengal Contract Labour ( Regulation and Abolition ) Rules, 1972 as will be forced from time to time. If no labour license is obtained and produced by the contractor payment will be liable to withhold.
28. If the last date of submission of tender is declared as holiday, the tender will be received upto 13:00 hrs and will be opened immediately after work as usual.
29. Claimed for idle labour from contractor will not be entertained under any circumstances. No claim will be entertained for any increase in railway freight and market price.
30. The tenders received after the due date & time and any change in quotation after opening of the tender will be outrightly rejected. The department will not be responsible for the loss of tender form or the delay in the Postal transit.
