Expression of Interest for preparation of DPR on execution for Electrical works inside and outside of all the infrastructure facilities and playground for lighting arrangement of Plessey Sports School, Nadia (W.B.).

Expression of interest is invited in sealed two cover system for preparation of DPR for the project proposal on execution for Electrical works of Sports School complex with assistance of fund of MA&ME Deptt. Govt. of West Bengal from the Chartered Engineers (Electrical), Consultants, Electrical Engineer having adequate experience.

Terms and conditions of EOI.

(1) (a) **Earnest money** : Of EOI

Earnest Money : Rs. 10,000/- (Rupees ten thousand) only earnest money will be drawn in favour of F.C & C.A.O., Nadia Zilla Parishad by A/C payee demand draft on a Nationalized bank with a branch at Krishnagar, Dist.- Nadia (W.B.) It will be submitted at the time of formal agreement by the lowest Bidder.

(2) **Validity of EOI**: The offer will remain valid of acceptance for 180 days from the date opening of EOI.

(3) **Last date of submission of application for collection of EOI documents**: - **21/11/16**

(4) **Cost of EOI documents**: Dose not arise.

(5) **Last date and time for Submission of EOI** : **23/11/16.**

(6) **Time and date of opening of EOI** : (i) Technical bid.-24/11/16
(ii) Financial bid.-24/11/16

(7) No allowance is entitled to visit the site for preparation of DPR.

(8) **Mode of Payment for preparation of DPR:-**

(i) 50% payment would be made on estimated cost after vetting DPR.

(ii) 25% payment would be made after the project is grounded.

(iii) 25% payment would be made after completion of the project.

(9) **The consultant is liable to make DPR fruitful vetting by the competent Authority. Estimating BOQ of DPR be cost effective.**

The DPR will be vetted by competent Authority.

The consultant will contact Station Manager, WBSEDCL for service connections and other aspect for preparing a report of electrical parameters of WBSEDCL Line which will be enclosed with the DPR.

(10) **Single line circuit diagram of all electrical works would be available with the DPR.**

(11) **Late EOI** :-

Any EOI received after the stipulated time, will not be accepted.

(12) **EOI Opening** :-

The EOI will be opened (Except those received late) in the presence of the bidders/ bidder's representatives who chose to attend at the specified time, date & place. In the event of the specified date for the submission of bids being declared a holiday the bid will be opened at the appointed & location on the next working day.

The envelop containing the technical bid shall be opened first.

In all other cases, the validity shall be announced. Thereafter the bidder's name and such other details as may be considered appropriate will be announced at the opening.

A list of bidders, whose technical bids are found responsive, will be displayed if required in the office notice board prior to the schedule date of opening of financial bid. In case the specified date is deferred a corrigendum notice will be published and will be displayed in the office notice board.

At the time of opening of the 'Financial Bids' the name of the eligible bidders will be announced.

The financial bids of only those bidders will be opened. The remaining bids will be returned unopened to the bidders.

(13) Guideline for preparation of DPR :-

(A) DPR of this project proposal consists of the following basis guidelines to be implemented by the consultant electrical work of all.

(i) It will be lighting illumination arrangement of ground compound and electrical works of infrastructure facilities. In this regard respective drawings as and when required are also available from the employer.
