A amount of Rs.1773.760 lakhs (Rupees Seventeen Crore Seventy Three lakhs Seventy Six thousand) only Rs. 1900.00 lakhs (Rupees Nineteen Crore) only has been received as Centre share of Grant- in-aid under Total Sanitation Campaign for Nadia2013-2014 vide G.O.s No. WBSRDA/TSC/2013-14/12-RD/PH&S/S/1E-1/11 dated 12-03-2014, WBSRDA/TSC/2013 14/11-RD/PH&S/S/1E-1/11 dated 12-03-2014, WBSRDA / TSC / 2013-14 / 10- RD/PH&S/S/1E-1/11 dated 12-03-2014, WBSRDA/TSC/2013-14/07 RD/PH&S/S/1E-1/11 dated 06-03-2014, WBSRDA/TSC/2013-14/08-RD/PH&S/S/1E-1/11 dated 06-03-2014 and WBSRDA/TSC/2013-14/09-RD/PH&S/S/1E-1/11 dated 06-03-2014 from the Panchayat & Rural Development Department, from the Panchayat & Rural Development Department is hereby sub- allotted to the Executive Officers of all Panchayat Samities as per detailed statement attached in Annexure - A & B. The allotment includes material component payment for IHHL.

Guideline for utilization of fund allotted:- **[As per letter vide memo no. J-11107/41/2011-MGNREGA (Pt.) dated June, 13 of Shri Rajesh Bhushan, Jt Secy, MGNREGA]**

- BDOs and Executive Officer will approve the cluster-wise name of beneficiaries prepared by Executive Assistant/Nirman Sahayak/Secretary which should be strictly at par with list of BPL and Identified APL families without toilet emerged from Baseline Survey, 2013. During the collection of beneficiaries' contribution, if it is found that beneficiary has got sub-sidy in earlier, under no circumstances sub-sidy will be given further. Only sub-sidy will given that beneficiary who has not get sub-sidy till date. BDO & PO will give a unique ID to each work as any other MGNREGS work and treat the whole IHHL work as a Single MGNREGS Work.
- BDOs and Executive Officer will act as Programme Officer and GPs will act as P.I.A. and Sanitary Marts will act as Supporting Agency of G.P. Hence all formalities of MGNREGA to be strictly observed.
- BDOs and Executive Officer will set target for each G.P as per their allocation figure.
- BDOs and Executive Officer will release MGNREGA component for wages part to the G.P.s concerned and NBA component for material part to the respective R.S.M.s without any delay. As per existing guideline, 60% advance may be given to the Sanitary Marts against their assigned no of works.
- Sanitary Marts will act as Supporting Agency as well as Supervisor for each work or cluster of works and obtain Muster Roll, M.B.s, Expenditure details from G.P.s and after completion of work, will submit the same after duly filling up. After receiving such G.P. will cause for payment of labours as per norms of MGNREGS.
- BDOs and Programme Officer will monitor the progress and cause web-entry for both NREGA-Soft and IMIS of NBA web-site through G.P.s after completion of works.
